Governing Law

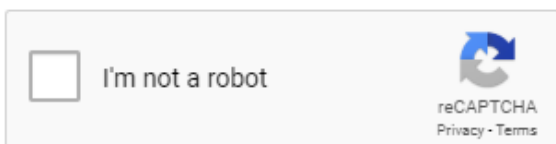
